

ORDINANCE 04-15-14

ORDINANCE AUTHORIZING THE SALE OF DRAFT OR KEG BEER  
OR MALT BEVERAGES WITHIN THE CORPORATE LIMITS  
OF THE CITY OF ENTERPRISE

**WHEREAS**, Alabama Act No. 2014-265 provides that the City of Enterprise, in Coffee and Dale County, may authorize the sale of draft or keg beer or malt beverages by properly licensed retailed licensees of the Alcoholic Beverage Control Board; and

**WHEREAS**, all resolutions and ordinances relating to the sale, consumption, and possession of bottled or canned beer shall apply to draft or keg beer or malt beverages; and


**WHEREAS**, the City of Enterprise City Council may adopt an ordinance regulating the sale of draft or keg beer or malt beverages pursuant to Alabama Act No. 2014-265;


**NOW, THEREFORE BE IT ORDAINED** by the City of Enterprise City Council as follows:


Section 1: That effective upon adoption and publication as required by law, the sale of draft or keg beer or malt beverages for on-premises consumption or off-premises consumption, or both, within the corporate limits of the City of Enterprise is authorized for retail licensees of the Alcoholic Beverage Control Board whose licenses permit said sale. All City resolutions and ordinances relating to the sale, consumption, and possession of bottled or canned beer shall apply to draft or keg beer or malt beverages and draft or keg beer and malt beverages are deemed to be included in the definition of alcoholic beverages as those terms are defined in said resolutions and ordinances.





ENROLLED, An Act,

Relating to the City of Enterprise in Coffee and Dale Counties; authorizing the sale of draft or keg beer or malt beverages by properly licensed retail licensees of the Alcoholic Beverage Control Board upon the consent of the City of Enterprise City Council.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. This act shall only apply to the City of Enterprise in Coffee and Dale Counties.

Section 2. The sale of draft or keg beer or malt beverages by retail licensees of the Alcoholic Beverage Control Board is authorized in the City of Enterprise. All resolutions and ordinances relating to the sale, consumption, and possession of bottled or canned beer in the town shall apply to draft or keg beer or malt beverages. The City of Enterprise City Council may adopt an ordinance regulating the sale of draft or keg beer or malt beverages pursuant to this act.

Section 3. All laws or parts of laws which conflict with this act are repealed. However, the provisions of this act are cumulative and supplementary and shall not be construed to repeal or supersede any laws or parts of laws not directly inconsistent herewith.
