

ORDINANCE 04-15-14-A

AN ORDINANCE PROVIDING FOR AMENDMENT OF ORDINANCE 12-18-84, ARTICLE VI, SECTION 7-61 TO PROVIDE FOR THE AMENDMENT TO THE LEVY OF LICENSE FEE SCHEDULE TO INCLUDE BREW PUBS AND MANUFACTURERS AND TO PROVIDE THAT THE ALABAMA ABC LICENSE SCHEDULE RATE WILL APPLY, UNLESS OTHERWISE ADDRESSED IN CITY ORDINANCES AND RESOLUTIONS, FOR LICENSES NOT SPECIFICALLY INCLUDED IN THE SCHEDULE

Be It Ordained by The City Council of the City of Enterprise, Alabama, that Ordinance 12-18-84, Article VI, Section 7-61 providing for the Levy of License fee is hereby amended as follows:

I. Liquor , Wine, and Beer License Schedule

- (1) Importer's License.....\$ 250.00
- (2) Liquor Wholesale License.....400.00
- (3) Wholesale Beer License.....250.00
- (4) Wholesale Wine License.....275.00
- (5) Wholesale Beer and Wine License.....375.00
- (6) Warehouse License.....100.00
- (7) Lounge Retail Liquor License.....600.00
- (8) Restaurant Retail Liquor License.....600.00
- (9) Club Liquor License
 - Class I.....1000.00
 - Class II.....1250.00
- (10) Retail Table Wine License
(Consumption Off Premise).....75.00
- (11) Retail Table Wine License
(Consumption On or Off Premise).....75.00
- (12) Retail Beer License
(Consumption On or Off Premise).....75.00
- (13) Retail Beer License
(Consumption Off Premise).....50.00
- (14) Special Retail License
 - 30 Days or Less.....100.00
 - More Than 30 Days.....250.00
- (15) Special Events Retail License.....150.00
- (16) Brew Pub License.....1000.00
- (17) Manufacturer.....500.00
- (18) Other (Not Listed).....Alabama ABC License Schedule Rate

II. Liquor, Wine, and Beer Licenses Not Included in Schedule

For any other liquor, wine, or beer licenses not included in this schedule or not addressed in any other city ordinance or resolution, the rate schedule established by the State of Alabama Alcoholic Beverage Control Board shall apply.

III. Severability.




III. Effective Date.


This ordinance shall take effect upon its approval by the City Council, or upon its otherwise becoming law, but shall nevertheless be published as required by law.
